**ORDINANCE No. 464-2023**

**AN ORDINANCE OF THE BOROUGH OF SHOEMAKERSVILLE, BERKS COUNTY, PENNSYLVANIA, AUTHORIZING AND DIRECTING THE BOROUGH TO ENTER INTO A NOTE MODIFICATION AGREEMENT WITH CUSTOMERS BANK TO REPLACE THE 30 DAY LONDON INTERBANK OFFERING RATE (“LIBOR”) RATE WITH THE 30 DAY SECURED OVERNIGHT FINANCING RATE (“SOFR”) RATE AS SET FORTH IN THE BANK’S PROPOSAL DATED APRIL 28, 2023.**
