AN ORDINANCE OF THE BOROUGH OF SHOEMAKERSVILLE, BERKS COUNTY, PENNSYLVANIA, REPEALING AND REPLACING ORDINANCE NUMBER 414, ENACTED ON APRIL 7, 2009 AND ANY AMENDMENTS THERETO, BY PROVIDING FOR: THE CREATION OF AN ADVISORY RECREATION BOARD; THE ESTABLISHMENT OF THE NUMBER AND TERMS OF THE MEMBERS; RESIDENCY REQUIREMENTS AND THE DESIGNATED DUTIES AND POWERS OF THE BOARD.
